I. General Information

New Jersey Alternate Route CTE CE EPP

This program provides an opportunity for people with diverse educational, training and employment backgrounds to become Career and Technical Education (CTE) teachers. Career and Technical Education programs are secondary school programs that prepare students for training, employment, or postsecondary education in newly developed occupations and existing professions. Individuals who have a Bachelor's degree, an Associate's degree and two years employment experience, or who have four years employment experience may be candidates for this program.

On September 1, 2017, the NJDOE introduced significant changes to all teacher certification programs in the state. These changes resulted in the expansion of the CTE Alternate Route Program from a 200 hour program to the new Career and Technical Education Certificate of Eligibility Educator Preparation Program (CTE CE EPP), a two year, 400-Hour program which includes a 50 hour pre-service component referred to as the 50-Hour Pre-Professional Experience. The 400-hour program is comprised seven stages, the first stage being the 50-Hour Pre-Professional Experience.

Brookdale Community College offers **Stage I, the 50-Hour Pre-Professional Experience**, several times a year. The program will be delivered in two formats, the Traditional Model which will be delivered by Brookdale Community College and the County Vocational School Partnership Model which will be delivered in conjunction with those partnering school districts.

The **350-Hour component** of the CTE CE EPP is delivered as Year 1 (**Stages II-IV**) and Year 2 (**Stages V-VII**) and consists of approximately twelve-week sessions each stage. Year 1 Cohorts begin in October, February, and April; each stage will follow shortly after previous stage end dates.

The CTE CE EP Program runs in a hybrid format. The program is taught partly on-line and partly in a virtual classroom instructional setting. Virtual classroom instruction will be held over a period of several "Virtual Cohort Saturdays" and attendance is mandatory.

The program provides an opportunity for students enrolled in Stages II-VII to earn <u>28 undergraduate</u> college credits toward an Associate's Degree and teacher certification, or teacher certification only. The credits earned may be applied toward the Technical Education AAS from Brookdale Community College. Candidates who enroll in the credit option of the program must submit additional fees and documents to complete registration. The full 28 credits are awarded at the conclusion of the full 400-Hour program, upon successful completion of all stages and submission of the final credit portfolio.

More detailed credit option information will be provided to all candidates as they enroll in and continue through the 350-Hour component of the program.

Basic Eligibility Requirements for enrollment in the CTE CE EPP are:

Stage I, the 50-Hour Pre-Professional Experience:

- May enroll with or without a Certificate of Eligibility;
- May enroll with or without employment as a CTE teacher;
- Candidates who have previously completed the 24-Hour Introduction to Teaching Pre-Service Program, or who have completed a 50-Hour program with another program provider may be credited up to 20 hours towards the 50-hour requirement if proper documentation is provided.

Stages II-VII, the 350-Hour Program Component:

- Must already have completed the CTE CE EPP's Stage I, the 50-Hour Pre-Professional Experience;
- Must have a Certificate of Eligibility issued in a CTE subject area;
- Must have been hired to teach in their CTE subject area and enrolled in the NJDOE's Provisional Teacher Program (PTP).

Candidates must successfully complete a stage in order to advance to the next. Those who do not successfully complete a stage will be given the opportunity to re-enroll in that stage in order to successfully complete and advance in the program.

II. <u>How to obtain your Career and Technical Education Certificate of Eligibility</u> (CE)

There are multiple steps to qualify to become a Career and Technical Education (CTE) teacher candidate through the CTE alternate route provisional teacher program and to complete the requirements for standard certification. Alternate route candidates come from a wide variety of educational and employment backgrounds. If you decide to pursue this challenging career change, you will enjoy the camaraderie and support of a fascinating group of people as you go through the program.

Individuals who are interested in becoming a teacher in a CTE program must apply to the New Jersey Department of Education for a CTE Certificate of Eligibility (CE) in the subject area or "endorsement" that they are seeking to teach. You may apply if you have the required employment experience, self-employment experience, college degree or a combination of employment experience and education. College Degree:

When the CTE CE EPP applicant has a college degree, the degree must be in the subject area that the individual is seeking on the CE endorsement for which they are applying. For example, if the individual is seeking a CTE certificate of eligibility in culinary arts, they must have a degree in culinary arts, food service, etc.

Employment experience:

The CTE CE EPP applicant's employment experience, or self-employment experience must be in the occupation identified on the CE endorsement for which they are applying. For example, if the individual is applying for a CTE certificate of eligibility in carpentry, they must have employment experience, or self-employment experience as a carpenter. It should be noted that if an individual is required by the State of New Jersey to hold an *occupational license or certificate for employment*, then the applicant must also have a current *occupational license or certificate for employment* in addition to meeting the educational and/or employment experience requirements for the CTE certificate of eligibility.

Applying for a CTE Certificate of Eligibility with a Bachelor's Degree or Higher Level Degree

1. Submit College Transcripts

The applicant must submit to the NJDOE an official transcript from each accredited college or university attended. The transcript must show 30 credits in a coherent sequence of courses in the subject area for which the individual is applying, as well as a cumulative GPA of at least 3.00 when a GPA of 4.00 equals an A grade for students graduating on or after September 1, 2016 (2.75 for those graduating before September 1, 2016) in a baccalaureate degree program, higher degree program or a State-approved post-baccalaureate certification program with a minimum of 13 semester-hour credits. *If the applicant is using employment experience, even if they have a relevant four-year degree, they are exempt from this requirement.*

Individuals who hold an associate's degree, bachelor's degree or higher level degree, are not required to take a PRAXIS exam unless they are seeking certification in Business, Marketing, Family and Consumer Sciences, or Industrial Technology. Individuals who are seeking these certifications must take the PRAXIS II exam in the appropriate subject area and submit their Praxis exam scores to the NJDOE as part of the CE application process. For Praxis exam information, use the following link: www.ets.org/praxis. *Always consult the NJDOE for testing information and requirements.

2. Take the Physiology and Hygiene Test

If your transcript does not indicate study in any of the following areas, you must go to a County Office of Education and take the Physiology and Hygiene Test. You may be exempt from this test if you can present evidence of basic military training or college level study in areas such as biology, health or nutrition.

The areas of college study that exempt you from taking this test are: human biology, personal health problems, community health, school health, family health, health counseling, nutrition, or health

administration. If you are not certain you have fulfilled this requirement in your college studies, we suggest you take the test so your CE is not delayed.

3. Apply for the CE

Applying for a CTE Certificate of Eligibility with an Associate's Degree and Employment Experience

1. Submit College Transcripts

The applicant must submit to the NJDOE an official Associate's degree transcript from an accredited college or university. The transcript must show 30 credits in a coherent sequence of courses in the subject area for which the individual is applying, as well as a cumulative GPA of at least 3.00 when a GPA of 4.00 equals an A grade for students graduating on or after September 1, 2016 (2.75 for those graduating before September 1, 2016).

2. Submit evidence of at least two years of employment experience

The applicant must submit evidence of at least two years of employment experience (approximately 4000 hours) in the occupational field of the endorsement for which they are applying for their CE. The employment experience must:

- a. Have occurred within 10 years of the CE application date
- b. Be documented and verified by the applicant's employer(s) on the NJDOE "Statement of Employment Experience" form found on the following link: <u>https://www.nj.gov/education/license/forms/voc_employer_experience.pdf</u>

3. Take the Physiology and Hygiene Test

If your transcript does not indicate study in any of the following areas, you must go to a County Office of Education and take the Physiology and Hygiene Test. You may be exempt from this test if you can present evidence of basic military training or college level study in areas such as biology, health or nutrition.

The areas of college study that exempt you from taking this test are: human biology, personal health problems, community health, school health, family health, health counseling, nutrition, or health administration. If you are not certain you have fulfilled this requirement in your college studies, we suggest you take the test so your CE is not delayed.

4. Apply for the CE

Applying for a CTE Certificate of Eligibility with Employment Experience Only

1. Submit evidence of at least four years of employment experience

The applicant must submit evidence of at least four years of employment experience (approximately 8000 hours) in the occupational field of the endorsement for which they are applying for their CTE CE. The employment experience must:

- a. Have occurred within 10 years of the CE certificate application date
- b. Be documented and verified by the applicant's employer(s) on the NJDOE "Statement of Employment Experience" form found on the following link: <u>https://www.nj.gov/education/license/forms/voc_employer_experience.pdf</u>

If applying for a CTE Certificate of Eligibility using self-employment:

In place of item "b" above, you must submit documentation with a notarized letter from a tax preparer and/or attorney verifying that you have filed state and/or federal taxes for the self-employment using a federal U.S. Census North American Industry Classification System (NAICS) code in the occupational field of the endorsement. 2. Take the Physiology and Hygiene Test

You must pass a Physiology and Hygiene test including the effects of narcotics and alcohol administered by the county offices of education. You may be exempt from this test if you can present evidence of basic military training or college level study in areas such as biology, health or nutrition.

The areas of college study that exempt you from taking this test are: human biology, personal health problems, community health, school health, family health, health counseling, nutrition, or health administration. If you are not certain you have fulfilled this requirement in your college studies, we suggest you take the test so your CE is not delayed.

III. Applying to the CTE CE EPP's Stage I, the 50-Hour Pre-Professional Experience

Individuals who are seeking or who have been issued a Career and Technical Education Certificate of Eligibility (CTE CE) must enroll in Stage I, the 50-Hour Pre-Professional Experience as part of the 400-Hour CTE CE EPP.

Individuals can apply to Stage I, the 50-Hour Pre-Professional Experience, by completing the CTE CE EP Program Application found on the Brookdale Community College, Career and Technical Education Certificate of Eligibility Educator Preparation Program webpage. Applicants who have already completed a 24-Hour Introduction to Teaching Pre-Service Program or another provider's 50-Hour program **must** provide a copy of their completion certificate in order to have 20 hours of coursework from that program credited toward the 50-Hour Pre-Professional Experience Program.

Applicants will need to submit a completed application and all applicable supporting documents to the CTE Office at Brookdale.

IV. <u>Applying to the Career and Technical Education Certificate of Eligibility</u> Educator Preparation Program – Stages II-VII

Continuation on to Stage II of the CTE CE EPP, and all subsequent stages, requires that you have met the following criteria:

- Have successfully completed Stage I, the 50-Hour Pre-Professional Experience, of the CTE CE EPP
- Have been issued a Certificate of Eligibility (CE) in a Career and Technical Education (CTE) subject area
- Have been hired to teach by a school district in their CTE CE subject area

<u>NOTE</u>: In order to be hired by a school district and enrolled in the NJDOE's Provisional Teacher Program, you must have a Certificate of Eligibility and provide your hiring district with a copy of your 50-Hour Verification of Program Completion (VOPC).

Enrollment in the Career and Technical Education Certificate of Eligibility Educator Preparation Program is one of many requirements of the NJDOE Provisional Teacher Preparation Program. Unless otherwise noted, it is the teacher candidate's responsibility to ensure all provisional requirements are met.

Applications to the Career and Technical Education Certificate of Eligibility Educator Preparation Program, (CTE CE EPP) are available at <u>www.brookdalecc.edu/cte</u> or by email at <u>cte@brookdalecc.edu</u>.

When advancing to Stage II of the CTE CE EPP, candidates will be required to submit a completed Stage II Registration Form with a copy of the following documents:

- Copy of CTE Certificate of Eligibility (if not previously submitted)
- Copy of Employment Contract or letter from hiring district indicating the dates of employment and subject area being taught (*if not previously submitted*)

Candidates <u>must</u> maintain employment as a teacher in their CTE endorsement area to continue with the CTE CE EPP and may be asked to provide an updated employment contract before any stage.

All required documents must be submitted to the CTE Office at Brookdale for review. Candidates who meet the eligibility requirements will be admitted to the CTE CE EPP. Registration and payment procedures, current fees and program dates/times, and other relevant information will be provided to all candidates at time of acceptance. Upon acceptance to the program, students must complete a Registration Form and remit payment for their respective stage.

Candidates will be offered two options for the program:

- **Credit option:** Brookdale Community College provides CTE CE EPP students with the option of earning *28 undergraduate credits* that can be used toward a Technical Education AAS degree from Brookdale Community College, in addition to completing the program hours for certification.
- Noncredit option: For certification only.

NOTE: The course requirements and workload are the same for both options. Both equally fulfill the New Jersey Department of Education (NJDOE) alternate route requirements for teacher certification. Upon completion of the 400-Hour Program, all candidates will receive the same VOPC confirming their completion of instructional hours for submission to the NJDOE.

V. <u>Stage I</u>

Stage I of the CTE CE EPP is the first step in the Standard Certification process for CTE provisional teachers and will provide the student with an understanding of the teaching profession, present the realities of teaching as a career, and prepare the student for classrooms of diverse learners.

Stage I represents the 50-Hour component and is comprised of two "Virtual Cohort Saturday" sessions (dates announced by stage), as well as several online sessions. *Attendance at all Virtual Cohort*

Saturdays and completion of the online component is mandatory. Students are expected to arrive on time for the Virtual Cohort Saturdays and remain until class has ended. Attendance in the online component requires timely participation within the *weekly deadlines* for each session.

The student's successful completion of Stage I of the CTE CE EPP, acquisition of a CTE Certificate of Eligibility (CE), and employment by a school district in their CTE CE subject area will allow the candidate to continue on to the 350-Hour component (Stages II-VII) of the program.

VI. Stages II-VII

Stage II is the first of the six remaining stages that comprise a total of 350 hours of instruction that includes eighteen "Virtual Cohort Saturday" sessions, as well as online sessions that occur between Cohort Saturday meetings.

During Stages II-VII, students will be prepared to implement effective teaching practices in a career and technical education program classroom setting. The coursework will prepare the student in the areas of classroom management, strategies for instruction, differentiated instruction, and the application of curriculum theory. *Attendance at all Virtual Cohort Saturdays and completion of the online component is mandatory*. Students are expected to arrive on time for the Virtual Cohort Saturdays and remain until class has ended. Attendance in the online component requires timely participation within the *weekly deadlines* for each session.

Stages II-VII of the CTE CE EPP will provide a support system as well as an environment in which to share relevant experiences with other students in the cohort. The program will focus in greater depth on many of the topics that were introduced in Stage I, such as the principles of effective instruction, exploration of effective implementation strategies, and the importance of literacy across the curriculum.

To successfully complete CTE CE EPP program, students must fulfill all of the program requirements including the production of a Professional Improvement Development Plan (PDP) and teacher portfolio.

Several CTE CE endorsement areas require an **edTPA Performance Assessment** for state licensure (currently Agriculture, Business, Family and Consumer Sciences, and Marketing). While the CTE CE EPP does not administer or score the assessment, a copy of the edTPA score report must be submitted to the CTE office at Brookdale as part of successful program completion. These scores may be sent at any time during enrollment in or upon completion of the CTE CE EPP. Score must also be submitted directly to the NJDOE as part of the candidate's Standard Certificate application. When required, the performance assessment score must be noted on the VOPC by the program provider for the form to be considered valid. Upon successful completion of the program and all requirements, students will receive an original copy of their NJDOE Verification of Program Completion (VOPC). The VOPC will serve as verification of the successful completion of 400-Hours of alternate route instruction, which is one of the requirements of the NJDOE for issuance of a Standard Teaching Certification.

VII. Glossary of Terms

Alternate Route: An alternate certification process that permits qualified individuals who have not completed a traditional teacher training program to earn instruction licenses while teaching in schools under a program of mentoring supervision, evaluation and formal instruction.

CANVAS: Online learning management system through which the online sessions of the CTE CE EP Program are conducted.

Career and Technical Education Certificate of Eligibility Educator Preparation Program (CTE CE EPP): An alternate route certification program that provides an opportunity for people who have not completed a traditional teacher education program and who have varied educational, training and employment backgrounds to become Career and Technical Education (CTE) program teachers.

Career and Technical Education Provisional Teacher Program (PTP): A combination of alternate route teacher training, support and evaluation for first year Career and Technical Education teachers. Teacher candidates must be enrolled by their district in the PTP and enrolled in the CTE CE EPP.

Career and Technical Education Teacher: These individuals teach in Career and Technical Education high schools (formerly vo-tech) or may teach in comprehensive high schools that offer CTE programs.

Certificate of Eligibility (CE): Document issued by the NJDOE that shows the person has the qualifications to teach in New Jersey and may seek employment in the subject area/s indicated. This is NOT a teaching license.

Cohort Saturday: Scheduled virtual instruction with instructor and members of respective cohort. Meet approximately one Saturday per month. **Attendance is mandatory.**

Credit Option: Option through which a student may earn <u>28 undergraduate credits</u> towards a Technical Education associates degree upon successful completion of the full 400-Hour Career and Technical Education Certificate of Eligibility, Educator Preparation Program (CTE CE EPP).

edTPA: A performance-based, subject-specific assessment and support system used by teacher preparation programs throughout the United States. Assessments emphasize, measure, and support the skills and knowledge that all teachers must have in the classroom, and focus on three tasks: Planning, Instruction, and Assessment. Teachers must prepare a portfolio of materials during their provisional teaching experience which are submitted to and scored by edTPA.

Noncredit Option: The option by which students may elect to enroll in the CTE CE EPP to receive certification only for their program completion. There are no college credits earned.

NJDOE: New Jersey Department of Education

Core Academic Skills for Educators Exam: The Core Academic Skills for Educators exams are administered by Education Testing Services (ETS) and are designed to test an individual's knowledge in a specific subject area. For certain CTE endorsements there are subject area tests required (Business, Marketing, Family and Consumer Sciences, Industrial Technology and Technology Education). Most CTE endorsements do not require a subject area test, but do require Core Academic Skills for Educators tests in Reading, Writing and Mathematics to determine competency in these areas.

Provisional License: Two-year license that allows first year teachers to begin working in the classroom and legalizes employment. Upon employment, the school enrolls the new teacher in the Provisional Teacher Program. Under certain circumstances the provisional license can be extended.

Standard Certification: The permanent credential that allows the holder to serve without condition in all New Jersey schools. The standard license is issued after meeting all requirements of the provisional license.

Technical Education AAS: The Technical Education A.A.S. program allows CTE CE EPP students the opportunity to obtain credit for the CTE CE EPP curriculum and apply the credit toward completion of an Associate Degree. The Technical Education A.A.S. program is designed so that students with prior work experience and apprenticeship training may apply technical credits approved by the American Council on Education (or other agencies that convert training to college credit) toward completing the degree.
