The Required Clery Crime /Reporting Classifications Per

The Clery Act are [per the National Incident-Based Reporting System Edition of the Uniform Crime Reporting Program]:

SEX OFFENSES—FORCIBLE

Any sexual act directed against another person, without consent of the victim, including instances where the victim is incapable of giving consent.

Forcible Rape

The penetration, no matter how slight, of the vagina or anus, with any body part or object, or oral penetration by a sex organ of another person, without the consent of the victim. This offense includes the rape of both males and females.

Forcible Sodomy

Oral or anal sexual intercourse with another person, forcibly and/or against that person's will; or not forcibly against the person's will where the victim is incapable of giving consent because of his/her youth or because of his/her temporary or permanent mental or physical incapacity.

Sexual Assault with an Object

The use of an object or instrument to unlawfully penetrate, however slightly, the genital or anal opening of the body of another person, forcibly and/or against that person's will; or not forcibly or against the person's will where the victim is incapable of giving consent because of his/her youth or because of his/her temporary or permanent mental or physical incapacity.

Forcible Fondling

The touching of the private body parts of another person for the purpose of sexual gratification, forcibly and/or against that person's will; or, not forcibly or against the person's will where the victim is incapable of giving consent because of his/her youth or because of his/her temporary or permanent mental or physical incapacity.

SEX OFFENSES—NON-FORCIBLE

Unlawful, non-forcible sexual intercourse.

Incest

Sexual intercourse between persons who are related to each other within the degrees wherein marriage is prohibited by law.

Statutory Rape

Non-forcible sexual intercourse with a person who is under the statutory age of consent.

As Per the Uniform Crime Reporting Handbook

Aggravated Assault: an unlawful attack by one person upon another for the purpose of inflicting severe or aggravated bodily injury. This type of assault usually is accompanied by the use of a weapon or by means likely to produce death or great bodily harm. It is not necessary that injury result from an aggravated assault when a gun, knife, or other weapon is used which could or probably would result in a serious potential injury if the crime were successfully completed.

Arson: Any willful or malicious burning or attempt to burn, with or without intent to defraud, a dwelling, house, public building, motor vehicle or aircraft, personal property, etc.

Burglary: The unlawful entry of a structure to commit a felony or a theft. For reporting purposes this definition includes: unlawful entry with intent to commit a larceny or a felony; breaking and entering with intent to commit a larceny; housebreaking; safecracking; and all attempts to commit any of the aforementioned.

Motor Vehicle Theft: The theft or attempted theft of a motor vehicle. (Classify as motor vehicle theft all cases where automobiles are taken by persons not having lawful access even though the vehicles are later abandoned-including joy riding).

Murder and Non-negligent Manslaughter: The willful (non-negligent) killing of one human being by another.

Manslaughter by Negligence: The killing of another person through gross negligence.

Robbery: The taking or attempting to take anything of value from the care, custody, or control of a person or persons by force or threat of force, violence, and/or causing the victim fear.

Weapon Law Violations: The violation of laws or ordinances dealing with weapon offenses, regulatory in nature, such as: manufacture, sale, or possession of deadly weapons; carrying deadly weapons, concealed or openly; furnishing deadly weapons to minors; aliens possessing deadly weapons; all attempts to commit any of the aforementioned.

Drug Abuse Violations: Violations of state and local laws relating to the unlawful possession, sale, use, growing, manufacturing, and making of narcotic drugs. The relevant substances include: opium or cocaine and their derivatives (morphine, heroin, codeine); marijuana; synthetic narcotics (demerol, methadones); and dangerous non-narcotic drugs (barbiturates, benzedrine).

Liquor Law Violations: The violation of laws or ordinance prohibiting: the manufacture, sale, transporting, furnishing, possessing of intoxicating liquor; maintaining unlawful drinking places; bootlegging; operating a still; furnishing liquor to minor or intemperate person; using a vehicle for illegal transportation of liquor; drinking on a train or public conveyance; all attempts to commit any of the aforementioned. (Drunkenness and driving under the influence are not included in this definition.)

Larceny: The unlawful taking, carrying, leading, or riding away of property from the possession or constructive possession of another.

Hate/Bias Crimes: Hate crimes are any of those listed above, or any crime that involves any of the above or any that involves bodily injury, larceny, theft, simple assault, intimidation, or vandalism, in such a way as to manifest evidence that the victim was intentionally selected because of the perpetuator's bias. The categories of bias are: race, gender, religion, sexual orientation, ethnicity, or disability.

Simple Assault: An unlawful physical attack by one person upon another where neither the offender displays a weapon, nor the victim suffers obvious serve or aggravated bodily injury involving apparent broken bones, loss of teeth, possible internal injury, sever laceration or loss of consciousness.

Intimidation: To unlawfully place another person in reasonable fear of bodily harm through the use of threatening words and/or other conduct, but without displaying a weapon or subjecting the victim to actual physical attack.

Vandalism: To willfully or maliciously destroy, injure, disfigure, or deface any public or private property, real or personal, without the consent of the owner or person having custody or control by cutting, tearing, breaking, marking, painting, drawing, covering with filth, or any other such means as may be specified by local law.

Violence Against Women Act Definitions

Domestic Violence: Felony or misdemeanor crimes of violence committed by a current or former spouse of the victim, by a person with whom the victim shares a child in common, by a person who is cohabitating with or has cohabitated with the victim as a spouse, by a person similarly situated to a spouse of the victim under the domestic or family violence laws of the jurisdiction receiving grant monies, or by any other person against an adult or youth victim who is protected from that person's acts under the domestic or family violence laws of the domestic or family violence laws of the domestic or family violence laws of the jurisdiction.

Dating Violence: Violence committed by a person who is or has been in a social relationship of a romantic or intimate nature with the victim and where the existence of such a relationship shall be determined based on a consideration of the following factors: the length of the relationship, the type of relationship, the frequency of interaction between the persons involved in the relationship.

Stalking: Engaging in a course of conduct directed at a specific person that would cause a reasonable person to fear for his or her safety or the safety of others or suffer substantial emotional distress.

Crime Statistics

The information below provides context for the crime statistics reported as part of compliance with the Clery Act.

The procedures for preparing the annual disclosure of crime statistics include reporting statistics to the College community obtained from the following sources: the Brookdale Community College Police Department (BCCPD), the Middletown Township Police Department, the Hazlet Police Department, the Long Branch Police Department, the Wall Police Department, the Neptune Township Police Department, the Freehold Township Police Department, the Neptune Township Police, the Monmouth County Sheriff's Department, the New Jersey State Police, the Monmouth County Prosecutor's Office, and non-police officials, like the Monmouth County Park System/Rangers. For statistical purposes, crime statistics reported to any of these sources are recorded in the calendar year the crime was reported.

A written request for statistical information is made on an annual basis to all Campus Security Authorities (as defined by federal law) and to all College Deans, Directors, and Department Heads.

Statistical information is requested and sometimes provided to BCCPD by the employees at the College Counseling Center even though Professional Counselors and Pastoral Counselors are not considered to be 'CSAs,' nor required by law to provide statistics for the compliance document.

Members of the Monmouth County Sexual Assault Response Team (SART) also provide statistics to BCCPD about cases they have dealt with where the victim chose not to report the incident to BCCPD or MTPD.

Brookdale's Title IX Coordinator reports to the BCCPD reports of crimes, suspected/reported crimes, and Title IX incidents/investigations. The Title IX Coordinator for Brookdale is the Associate Vice President of Student Affairs and is located on the second floor of the CAR building. The Title IX Coordinator can be reached by phone at 732-224-2215. The Deputy Title IX Coordinator is the Manager of Student Conduct and Compliance, and is located on the second floor of the CAR building on the Lincroft campus, and can be reached by phone at 732-224-2096.

All of the statistics are gathered, compiled, and reported to the College community via this brochure/Annual Security Report, which is published by BCCPD. BCCPD submits the annual crime statistics published in this brochure to the Department of Education (ED). The statistical information gathered by the Department of Education is available to the public through the ED website.

BCC notifies every enrolled student and current employee on an annual basis about the availability of the brochure. This includes a brief summary of the contents of the brochure in addition to the website address where the brochure can be found on the internet at http://brookdalecc.edu/human-resources/police/jeanne-clery-disclosureof-statistics/ and information about where to locate a hard copy of the brochure.

Geography definitions from the Clery Act

On-Campus-Defined as: (1) Any building or property owned or controlled by an institution within the same reasonably contiguous geographic area and used by the institution in direct support of or in a manner related to the institution's educational purposes, including residence halls; and (2) Any building or property that is within or reasonably contiguous to the area identified in paragraph (1), that is owned by the institution but controlled by another person, is frequently used by students and supports institutional purposes (such as a food or retail vendor).

Non-Campus Building Or Property-Defined as: (1) Any building or property owned or controlled by a student organization that is officially recognized by the institution; or (2) Any building or property owned or controlled by an institution that is used in direct support of or in relation to the institution's educational purposes, is frequently used by students, and is not within the same reasonably contiguous geographic area of the institution.

Public Property-Defined as: All public property, including thoroughfares, streets, sidewalks, and parking facilities, that is within the campus or immediately adjacent to and accessible from the campus. The BCC crime statistics do not include crimes that occur in privately owned homes or businesses within or adjacent to the campus boundaries.

Off-Campus Crime

If another police department is contacted about criminal activity occurring off-campus involving BCC students, that department may notify BCCPD. However, there is no official policy requiring such notification. Students in these cases may be subject to arrest by another police department and Brookdale's Student Conduct and Judicial proceedings through the Office of Student Judicial Affairs.

Counting of Crimes - Specific Information about Classifying Crime Statistics

The statistics in this brochure are published in accordance with the standards and guidelines used by the FBI Uniform Crime Reporting Handbook and the relevant federal law (the Clery Act).

The number of victims involved in a particular incident is indicated in the statistics column for the following crime classifications: Murder/ [Non-Negligent Manslaughter and Negligent Manslaughter], Forcible and Non-Forcible Sex Offenses [Forcible Rape, Forcible Sodomy, Sexual Assault with an Object, Forcible Fondling, Incest, Statutory Rape], Aggravated Assault, Domestic Violence, Dating Violence, and Stalking. For example, if an aggravated assault occurs and there are three victims, this would be counted as three aggravated assaults in the crime statistics chart.

The number reflected in the statistics for the following crime categories includes one offense per distinct operation: Robbery, Burglary, Larceny, Vandalism, and Arson. For example, if five students are walking across campus together and they are robbed, this would count as one instance of robbery in the crime statistics chart.

In cases of Motor Vehicle Theft, each vehicle stolen is counted as a statistic.

In cases involving Liquor Law, Drug Law, and Illegal Weapons violations, each person who was arrested is indicated in the arrest statistics. The statistics captured under the "Referred for Disciplinary Action" section for Liquor Law, Drug Law, and Illegal Weapons violations indicates the number of people the Vice President of Student Success referred to the Director of Student Conduct and Compliance for disciplinary action for violations of those specific laws. Being "found responsible" for a violation includes a referral that results in a student being charged by Director of Student Conduct and Compliance, and a record of the action being kept on file.

The statistics in the Hate Crime charts are separated by category of prejudice. The numbers for most of the specific crime categories are part of the overall statistics reported for each year. The only exceptions to this are the addition of Simple Assault, Intimidation, and any other crime that involves bodily injury that is not already included in the required reporting categories. If a hate crime occurs where there is an incident involving Intimidation, Vandalism, Larceny, Simple Assault or other bodily injury, the law requires that the statistic be reported as a hate crime even though there is no requirement to report the crime classification in any other area of the compliance document. Note: A hate or bias related crime is not a separate, distinct crime, but is the commission of a criminal offense which was motivated by the offender's bias. For example, a subject assaults a victim, which is a crime. If the facts of the case indicate that the offender was motivated to commit the offense because of his/her bias against the victim's race, sexual orientation, etc., the assault is then also classified as a hate/bias crime.

Specific Information about the Crime Statistics Reported by BCC

The column "Reported to BCCPD" includes crime statistics from incidents that were reported to BCCPD. If an incident was reported to both BCCPD and Another PD, the statistics would be counted under the "Reported to BCCPD" column. Incidents reported to the Security Officers are also included in this column. The column "Reported to Another PD" includes crime statistics from incidents that were reported to Another PD but NOT reported to BCCPD. These incidents could have occurred on/in on-campus property, non-campus property or public property, as defined in the Appendix. The crime statistics provided by Another PD are provided based on the crime definitions in the NJ Crimes Code, not based on the Uniformed Crime Reporting Program (UCR)/National Incident Based Reporting System (NIBRS), as required by the federal law.

The column "Reported to Non-Police" includes crime statistics from incidents reported to Sexual Assault Response Team (SART) members or from officials at the institution who are defined by federal law as Campus Security Authorities because they have significant responsibility for student and campus activities, including, but not limited to, Community Directors, and the Director of Student Conduct and Compliance.

Crime statistics for the categories of larceny and vandalism are not required by law, but are still provided in the interest of informing the community about the most frequent crimes that occur at BCC. Only those incidents reported to BCCPD are captured in these statistics. BCCPD does not request these statistics from Another PD or other Campus Security Authorities. Statistics under the heading of "Referred for Disciplinary Action" include those individuals referred to the Director of Student Conduct and Compliance (DSC) for disciplinary action by the Vice President of Student Success Office. The numbers include incidents that are reported via BCCPD incident reports and reports provided directly to DSC from other members of the BCC community. Referrals include the number of people referred for disciplinary action by DSC and found responsible for violating those specific laws. Being "found responsible" is defined above.

For the Brookdale PD, the Chief of Police/designee will review, or cause to be reviewed, the classification of each and every call for service/Incident Report that occurs on a Brookdale property, to ensure that all crimes on the campus are properly accounted for and categorized.

Victim Assistance Services

If a BCC community member becomes the victim of a crime, the BCC Counseling Department offers direct services, assistance and referrals. The Counseling Department provides assistance to victims/survivors of a crime, by assisting them in obtaining the services they need to work

crime by assisting them in obtaining the services they need to work through and better understand their options. The Counseling Department works closely with other College offices and other outside agencies to assist the victim in receiving effective, comprehensive services and compassionate responses.

In addition, BCCPD officers offer information and guidance to victims when they file a BCCPD report.

Crime Prevention and Personal Safety Tips:

- Report all suspicious activity to BCCPD police officers or security officers immediately. You can either notify the Brookdale Police or Security by phone, by coming to their Headquarters/Security Desk, or by calling the Anonymous Tip Line at 1999 [on an internal BCC phone] (732) 224-1999, and student conduct issues via the Brookdale website. <u>https://www.brookdalecc.edu/vp-studentsuccess/conduct/</u>
- 2) Never take personal safety for granted. Anyone is a potential victim of a crime.
- 3) Try to avoid walking alone at night. Always be aware of your surroundings, employing situational awareness.
- 4) Always lock your vehicle's doors and close all vehicle windows, when unattended. Keep valuables in the trunk, where they cannot be seen.

- 5) Read and adhere to the information that is contained in any Timely Warning or Emergency Notification. The directions and suggestions therein can help keep you safe.
- 6) Possession of alcoholic beverages or illegal drugs is prohibited on campus. In general, avoid the use of alcohol or drugs. Persons under the influence are more likely to be the victims of a serious crime or accident.
- 7) Carry only small amounts of cash.
- 8) Never leave valuables (wallets, purses, books, book bags, calculators, etc.) unattended.
- 9) Lock up bicycles and motorcycles in the appropriate location.
- 10) Be aware of the wildlife in the area. Numerous animals are indigenous to the area of Brookdale's properties, especially Lincroft, which is surrounded by wooded areas. If you see an animal that seems to be ill or dangerous, call the Brookdale Police at either 732-224-2222 for a non-emergency, or at 9-1-1, if a possible emergency exists.
- 11) Engrave serial numbers or owner's recognized numbers, on items of value.

Sex Offender Registry

The Federal Campus Sex Crimes Prevention Act, enacted on October 28, 2000, requires institutions of higher education to issue a statement advising the campus community where law enforcement agency information provided by a State concerning registered sex offenders may be obtained. It also requires sex offenders, already required to register in a State, to provide notice, as required under New Jersey Code 2C: 7-12 to -19, of each institution of higher education in the State at which the person is employed, carries on a vocation, volunteers services or is a student. Smoking Policy

Brookdale Community College is a **Tobacco-Free college**. The use of tobacco is prohibited on all properties owned, leased, or otherwise utilized for College purposes and over which the College has control of the tobacco policy.

Other than smoking in one's own personal car, all tobacco products, including but not limited to cigarettes, cigars, pipes, **electronic cigarettes**, chewing tobacco, vaping, and/or snuff will be banned for use or consumption at all College locations. Anyone found violating this policy will be subject to a warning, arrest, and/or a Student Conduct violation/hearing.

Emergency Response

The College's Emergency Management Plan and Classroom Guidebooks provides information about, but not limited to, Closing the College; Telephone / Computer or Utility Failure; Media / Civil Disturbance / Student Disruptions; Hostage / School Violence; Basic First Aid Procedures or Response; Fire / Severe Weather / Shelter-in Place and Evacuation Guidelines; a Suspicious package / Envelope / Bomb or Bomb Threat and Areas of Rescue Assistance & Areas of Refuge.

College departments are responsible for developing contingency plans and continuity of operations plans for their staff and areas of responsibility. The College conducts numerous emergency response exercises each year, such as emergency lockdown and evacuation drills, tabletop or field exercises, and tests of the emergency notification systems on campus. These tests are designed to assess and evaluate the emergency plans and capabilities of the institution.

BCC police officers and supervisors have received training in Incident Command and Responding to Critical Incidents as well as Active Shooter on Campus. When a serious incident occurs that causes an immediate threat to the campus, the first responders to the scene are usually BCCPD, MTPD and the Lincroft Fire and Emergency Medical Services, and they typically respond and work together to manage the incident. Depending on the nature of the incident, other BCC departments and other local or federal agencies could also be involved in responding to the incident.

General information about the emergency response and evacuation procedures for BCC are publicized each year as part of the institution's Clery Act compliance efforts, and that information is available on the BCCPD website. Detailed information and updates to the BCC Emergency Management Guide Book are available on the BCCPD website at: <u>https://www.brookdalecc.edu/human-resources/police/</u> listed under the Emergency Preparedness tab.

Emergency Evacuation Procedures

Multiple evacuation drills are coordinated by BCCPD each semester for the Lincroft campus, and at least once per year at each Brookdale location, to test the emergency response of the community, the procedures, and the notification/alarm systems. Students learn the locations of the emergency exits in the buildings and are provided guidance about the direction they should travel when exiting each facility for a short-term building evacuation.

During drills, the community will be evacuated to established Evacuation Assembly Areas [EAAs], but the BCCPD does not tell the College community in advance about any possible long-term evacuations areas because those decisions are affected by time of day, location of the building being evacuated the availability of the various designated emergency gathering locations on campus, and other factors such as the location and nature of the threat. In all cases, BCCPD and staff on the scene will communicate information to students regarding the developing situation or any evacuation status changes.

The purpose of evacuation drills is to prepare building occupants for an organized evacuation in case of a fire or other emergency. At BCC, evacuation drills are used as a way to educate and train occupants on fire safety issues specific to their building. During the drill, occupants 'practice' drill procedures and familiarize themselves with the location of exits and the sound of the fire alarm. In addition to educating the occupants of each building about the evacuation procedures during the drills, the process also provides the College an opportunity to test the operation of fire alarm system components.

Evacuation drills are monitored by BCCPD, Facilities, the Brookdale Manager of Fire Safety and Environmental Compliance, and possibly by the local fire departments, to evaluate egress and behavioral patterns. Assessment Reports are prepared by the Brookdale Chief of Police/designee following each evacuation drill, so that the College may immediately identify and remedy deficient equipment or training/protocol shortfalls, Recommendations for improvements are also submitted to the appropriate departments/offices for consideration, both through emails and formal meetings. BCCPD conducts numerous announced and unannounced drills and exercises each year and conducts follow-through activities designed for assessment and evaluation of emergency plans and capabilities. BCCPD coordinates announced and unannounced evacuation drills each semester, as described above, to test the emergency response and evacuation procedures, and to assess and evaluate the emergency evacuation plans and capabilities. BCC will publish a summary of its emergency response and evacuation procedures in conjunction with at least one drill or exercise each calendar year.

Lockdown and Shelter-in-Place Procedures and Definitions

Shelter-In-Place:

If an incident occurs and the buildings or areas around you become unstable, or if the air outdoors becomes dangerous due to toxic or irritating substances, it is usually safer to stay indoors, because leaving the area may expose you to that danger. Thus, to "shelter-in-place" means to make a shelter of the building that you are in, and with a few adjustments this location can be made even safer and more comfortable until it is safe to go outside.

Basic "Shelter-in-Place" Guidance

If an incident occurs and the building you are in is not damaged, you will be directed to stay inside in an interior room until you are told it is safe to come out. If your building is damaged, take your personal belongings (purse, wallet, etc.) and follow the evacuation procedures for your building (close your door, proceed to the nearest exit, and use the stairs instead of the elevators). Once you have evacuated, seek shelter at the nearest College building quickly. If police or fire department personnel are on the scene, follow their directions.

How You Will Know to "Shelter-in-Place"

A shelter-in-place notification may come from several sources, including BCCPD, Facilities Staff members, other College employees, MTPD, or other authorities utilizing the College's emergency communications tools. Any Shelter-in-Place activation will involve an Emergency Notification message, as issued by the Brookdale Police Chief/Officer/designee.

How to "Shelter-in-Place"

No matter where you are, the basic steps of shelter-in-place will generally remain the same. Should the need ever arise; follow these steps, unless instructed otherwise by local emergency personnel:

- If you are inside, stay where you are. Collect any emergency shelterin-place supplies and a telephone to be used in case of emergency. If you are outdoors, proceed into the closest building quickly or follow instructions from emergency personnel on the scene.
- 2) Locate a room to shelter inside. It should be:

-An interior room;

-Above ground level; and

-Without windows or with the least number of windows. If there is a large group of people inside a particular building, several rooms maybe necessary.

- 3) If there is a need to secure the buildings or interior rooms, you will be notified via the emergency messaging system. Not every Shelter-In-Place will require the locking of doors.
- 4) Turn off air conditioners, heaters, and fans, or other actions, if directed to do so.
- 5) Close vents to ventilation systems, **if directed to do so.** (College Facilities staff will turn off the ventilation as quickly as possible.)
- 6) Make a list of the people with you and ask someone (Professor, faculty, or other staff) to call the list in to BCCPD so they know where you are sheltering. If only students are present, only one of the students should call in the list.

7) Monitor your cell phones for updates/subsequent messages.

8) Make yourself comfortable.

Lockdowns:

Lockdowns differ from Shelter-In-Place in that, in all such cases, the community will employ the principles of 'Run-Hide-Fight.' To keep oneself safe. Specifically, community members will choose to flee from an area [if safe to do so], barricade/lock one's self inside a protected area/room, and/or prepare to fight an assailant, as a last resort.

Lockdown drills are executed and evaluated each semester by the Brookdale College Community Police Department. An Assessment Report is generated proceeding each drill to remedy identified shortcomings in structural equipment, protocols, and/or performance.

Prior to each semester's emergency drills, a form is forwarded to each employee Brookdale, to assist each recall and follow the established protocols.

Education of Members of the College Community

Campus security and fire safety procedures are discussed during new student orientation. The BCC Police Department (BCCPD), the Vice President of Student Success Office, Director of Student Conduct and Compliance and other departments participate in forums, meetings, and programs to address students and to explain College security, public safety, and fire safety measures and procedures at BCC. Members of BCCPD conduct crime prevention and general security and safety awareness presentations when requested by various community groups. including students and employees of the College. During these presentations, the following information is typically provided: crime prevention tips; statistics on crime at BCC; fire safety information; information regarding campus security procedures and practices, including encouraging participants to be responsible for their own security/safety and for the security/safety for others on campus. In addition, BCCPD organizes and sets up crime prevention and education display tables which are staffed by an official(s) at various locations throughout the year. This activity provides an opportunity for BCCPD staff to hand out safety-related information, as well as to answer individual auestions. New employee orientation includes the distribution of crime prevention and materials to all new employees.

BCCPD utilizes a campus-wide state-of-the-art computerized monitoring system to monitor a comprehensive network of intrusion, panic, and fire alarm systems.

Alcohol and Drug Abuse Policy

BCC is an educational institution committed to maintaining an environment, which allows students to enjoy the full benefits of their learning experience and to understand the negative consequences of the illicit use of alcohol and drugs on their lives. In accordance with the policy approved by the Board of Trustees of the College, and in accordance with local, State, and federal laws, the College declares that it will make every effort to provide its students with an environment that is free of the problems associated with the unauthorized use and abuse of alcohol and illegal drugs. Substance abuse issues are addressed through the offering of topical programs throughout the year in order to provide members of the College community with information concerning health risks, legal sanctions and the like. The College is committed to promoting the wellness and self-development of its students. The unauthorized use and abuse of alcohol and the illegal use and abuse of drugs inhibits students from attaining the benefit of their learning experience, exposes them to serious illnesses and health risks, and therefore, is prohibited. Local, State, and federal laws that apply to underage consumption and use of drugs and alcohol (including motor vehicle violations) will be fully enforced at BCC.

Abuse of alcohol and drugs can have a dramatic impact on professional, academic, and family life. The College, therefore, encourages members of the community who may be experiencing difficulty with drugs or alcohol to contact one of the following resources available on-campus:

Preventing and Responding to Domestic Violence, Dating Violence, Sexual Assault, and Stalking

Brookdale Community College will not tolerate domestic violence, dating violence, sexual assault, stalking, or other forms of sexual misconduct. Offenders may be subject to appropriate campus adjudication processes, disciplinary action, and/or criminal proceedings. The College utilizes procedures that provide prompt, fair, and impartial investigation and resolution in cases involving domestic violence, dating violence, sexual assault, and stalking. These procedures are carried out by officials who receive specific annual training.

Sexual violence is a form of sexual harassment and services are available to students, faculty, and staff who experience sexual violence, domestic violence, dating violence, and instances of stalking.

In these situations, the College is committed to providing crisis intervention measures for students, faculty, and staff, as well as appropriate administrative response for the complainant and respondent; referring individuals to criminal authorities; and educating and promoting discussion on interpersonal abuse and violence issues. The College's process does not preclude adjudication under state law.

Brookdale Community College prohibits retaliation by its officers, employees, students, or agents against a person who exercises his or her rights or responsibilities under any provision federal or state law, including Title IX and the Violence Against Women Reauthorization Act (VAWA), or this policy.

Prevention Efforts

Brookdale Community College attempts to foster a safe learning and working environment for all members of the campus community. To accomplish this, the College considers the educational programming that addresses all aspects of domestic violence, dating violence, sexual assault, and stalking (safety precautions and prevention, crisis management, reporting, medical and counseling services, the College discipline systems, academic schedules, etc.), the campus response to sexual violence, domestic violence, dating violence, and instances of stalking, and physical surroundings throughout the campus community.

Brookdale Community College develops educational programs concerning domestic violence, dating violence, sexual assault, and stalking. Involved students, faculty, staff, and community members provide information and promote discussion on interpersonal abuse and violence issues. The Brookdale Community College Police Department (BCCPD) supports the educational programs by providing input and personnel to accomplish this task. For additional information about campus educational programs concerning domestic violence, dating violence, sexual assault, and stalking, contact the Title IX coordinator, Human Resources, or the Vice President of Student Success Office.

The College continually reviews and modifies its physical surroundings to enhance security and safety, such as campus lighting, locking procedures, signage, etc. For additional safety information, contact BCCPD at 732-224-2222.

How to be an Active Bystander

Bystanders play a critical role in the prevention of sexual and relationship violence. They are individuals who observe violence or witness the conditions that perpetuate violence. They are not directly involved but have the choice to intervene, speak up, or do something about it. We want to promote a culture of community accountability where bystanders are actively engaged in the prevention of violence without causing further harm. We may not always know what to do even if we want to help. Below is a list of some ways to be an active bystander. If you or someone else is in immediate danger, dial 9-1-1. This could be when a person is yelling at or being physically abusive towards another and it is not safe for you to interrupt.

• Watch out for your friends and fellow students/employees. If you see someone who looks like they could be in trouble or need help, ask if they are ok.

• Confront people who seclude, hit on, try to make out with, or have sex with people who are incapacitated.

• Speak up when someone discusses plans to take advantage of another person.

• Believe someone who discloses sexual assault, abusive behavior, or experience with stalking.

• Refer people to on or off campus resources listed in this document for support in health, counseling, or with legal assistance.

Risk Reduction Tips

With no intent to victim blame and recognizing that only rapists are responsible for rape, the following are some strategies to reduce one's risk of sexual assault or harassment.

• **Be aware** of your surroundings. Knowing where you are and who is around you may help you to find a way to get out of a bad situation.

• Try to **avoid isolated areas**. It is more difficult to get help if no one is around.

• Walk with purpose. Even if you don't know where you are going, act like you do.

• **Trust your instincts**. If a situation or location feels unsafe or uncomfortable, it probably isn't the best place to be.

• **Try not to load yourself down** with packages or bags as this can make you appear more vulnerable.

• Make sure your cell phone is with you and charged and that you have cab money.

• **Don't allow yourself to be isolated** with someone you don't trust or someone you don't know.

• Avoid putting music headphones in both ears so that you can be more aware of your surroundings, especially if you are walking alone.

• When you go to a social gathering, go with a group of friends. Arrive together, check in with each other throughout the evening, and leave together. Knowing where you are and who is around you may help you to find a way out of a bad situation.

• **Trust your instincts**. If you feel unsafe in any situation, go with your gut. If you see something suspicious, contact law enforcement immediately (local authorities can be reached by calling 9-1-1 in most areas of the U.S.).

• **Don't leave your drink unattended** while talking, dancing, using the restroom, or making a phone call. If you've left your drink alone, get a new one.

• **Don't accept drinks from people you don't know or trust**. If you choose to accept a drink, go with the person to the bar to order it, watch it being poured, and carry it yourself. At parties, don't drink from the punch bowls or other large, common open containers.

• Watch out for your friends, and vice versa. If a friend seems out of it, is way too intoxicated for the amount of alcohol they've had, or is acting out of character, get him or her to a safe place immediately.

• If you suspect you or a friend has been drugged, contact law enforcement immediately (local authorities can be reached by calling

9-1-1 in most areas of the U.S.). Be explicit with doctors so they can give you the correct tests (you will need a urine test and possibly others).

If you need to get out of an uncomfortable or scary situation here are some things that you can try:

• **Remember that being in this situation is not your fault**. You did not do anything wrong, it is the person who is making you uncomfortable that is to blame.

• **Be true to yourself**. Don't feel obligated to do anything you don't want to do. "I don't want to" is always a good enough reason. Do what feels right to you and what you are comfortable with.

• Have a code word with your friends or family so that if you don't feel comfortable you can call them and communicate your discomfort without the person you are with knowing. Your friends or family can then come to get you or make up an excuse for you to leave.

• Lie. If you don't want to hurt the person's feelings it is better to lie and make up a reason to leave than to stay and be uncomfortable, scared, or worse. Some excuses you could use are: needing to take care of a friend or family member, not feeling well, having somewhere else that you need to be, etc.

• **Try to think of an escape route**. How would you try to get out of the room? Where are the doors? Windows? Are there people around who might be able to help you? Is there an emergency phone nearby?

• If you and/or the other person have been drinking, you can say that you would rather wait until you both have your full judgment before doing anything you may regret later.

Reporting

The Title IX Coordinator receives complaints about alleged Title IX violations and is responsible for conducting a fair, timely and complete investigation of all such complaints. The Title IX Coordinator will advise the person reporting the incident about confidentiality, the investigative process and about potential outcomes and assistance options. A guiding principle in the reporting of domestic violence, dating violence, sexual assault, and stalking is to avoid possible re-victimizing of the complainant by forcing the individual into any plan of action. It is recommended that a person who has experienced domestic violence, dating violence, sexual assault, or stalking consider each of the following:

1. Getting to a safe place.

2. Avoiding the destruction of evidence by bathing, douching, changing clothes, or cleaning up in any way. Preserve evidence in a paper bag for possible future action. Also, keep copies of emails, text messages, and voice messages.

3. Pursuing medical treatment. Post-assault medical care can be performed at a local emergency room. Many hospitals have a specialized examiner who can complete an exam for victims of sexual violence. Such an exam can help the victim receive an appropriate medical assessment and treatment, and can preserve evidence for possible future action.

4. Pursuing counseling services with appropriate agencies (e.g., Brookdale Counseling Center, Employee Assistance Program (EAP) or private providers). Calling someone that is known and trusted, such as a friend or counselor, and discussing with this person the assault can help to evaluate the trauma to sort out next steps.

5. Making a police report. You can initiate a campus and/or criminal complaint. You may obtain assistance from campus authorities in this notification.

6. Making a report to a campus security authority (CSA), Title IX coordinator, deputy Title IX coordinator or other responsible employee under Title IX.

7. Making an anonymous report. An anonymous report to the police notifies them that an act of sexual violence has occurred but gives no names or identification.

Consider Filing a Police Report

A report to the police can empower the complainant by exercising her/his legal rights and can aid in the protection of others. The College staff will encourage the complainant to file a police report and will assist the complainant in notifying the police if requested. The police will then advise the complainant of the legal process.

1. On-campus investigation is typically conducted by BCCPD. BCCPD has both an administrative role and a law enforcement role.

2. Off-campus cases are usually investigated by other law enforcement agencies. When an investigation or legal proceedings occur off-campus, services are still available through Brookdale Community College.

There may be consequences to waiting to file a police report. Early reports may improve the preparation of a viable prosecution. Filing a police report immediately following the incident does not force the complainant to file charges and prosecute the respondent. However, it does aid in the preservation of valuable evidence if the complainant decides to pursue charges at a later date.

The State's Attorney makes all decisions regarding the prosecution of alleged crimes reported to law enforcement.

Alternatives to Immediately Filing a Police Report

1. Report the crime at a later date.

2. Make a complaint to a CSA, Title IX coordinator, or deputy Title IX coordinator. Such a complaint may be used for actions which include, but are not limited to, on-campus administrative proceedings.

3. Make an anonymous report to the police (a report that notifies the police that a domestic violence, dating violence, sexual assault, or stalking incident has occurred, but gives no names or identification).

4. Contact a referral agency for help: The Title IX coordinator, Human Resources and/or the Vice President of Student Success.

5. Make a complaint to the Title IX coordinator. Such a complaint may be used for actions which include, but are not limited to, on-campus administrative proceedings.

6. Contact the Title IX coordinator or a deputy Title IX coordinator for more information concerning the administrative process. Students may reference the campus judicial process in the Student Handbook under *Student Code of Conduct*. Faculty and staff may consult with Human Resources or the Title IX coordinator.

If the complainant does not choose to file a police report, s/he may still file an administrative complaint. The complainant will be referred to other agencies if appropriate. The complainant may decline to notify campus police and campus authorities.

Ongoing Care

Students may seek assistance at any time from the Brookdale Counseling Center at no additional charge. Any medical facility can assist with postassault medical care which includes testing and treating for sexually transmitted diseases (STDs). Costs for testing may be paid directly by the student or billed through insurance.

Benefited staff and faculty may seek assistance at any time from any medical facility or the Employee Assistance Program (EAP). Additionally, the Title IX coordinator may provide additional information. Any student, faculty, or staff member may seek assistance from the on-campus confidential advisor.

On-Campus Investigation and Adjudication

Brookdale's response to domestic violence, dating violence, sexual assault, or stalking incidents may involve a number of individuals and agencies. In addition, for cases involving campus community members, there is a timely, campus-based investigation which is private and protects individual rights and process. The complainant is presented with options about how s/he may pursue the complaint.

Title IX complainants, including those reporting violence or concerned about Brookdale's compliance with Title IX or Department of Education policies, may be directed to the Title IX coordinator in the Equal Employment Opportunity/Affirmative Action Office, Brookdale Community College 765 Newman Springs Rd. Lincroft, NJ 07738, or the U.S. Department of Education, 400 Maryland Avenue, SW, Washington, D.C. 20202. Complaints may also be directed to any other federal agency.

For Students

The *Student Code of Conduct* describes the procedures followed when a violation of the *Student Code of Conduct* is reported to the student conduct administrator (SCA). Reports of violence involving students are generally directed to the SCA Office, which manages investigations, and may act as a judicial officer when charges are brought.

Mediation, including referral to the Conflict Resolution Center for the purpose of mediation between the parties, will not be used to resolve sexual violence complaints.

The *Student Code of Conduct* outlines the process and protection of rights of both the complainant (the student who brings the grievance or makes the complaint) and the respondent (the student or individual about whom the grievance or complaint is brought). Both complainant and respondent have certain shared or complementary rights in disciplinary hearings. The rights below apply as addenda to the protocols identified in the *Student Code of Conduct*.

1. The complainant and the respondent have the right to be assisted by an advisor, including an advisor they choose at their own expense.

2. The complainant and the respondent have the right to access and review any information that will be used in the hearing.

3. The complainant and the respondent will be advised of the date, time, and location of a hearing, when scheduled. Both may attend and participate.

4. The SCA may accommodate concerns for the personal safety, wellbeing, and/or fears of confrontation of the complainant, respondent, and/or other witness during the hearing, in whatever manner and as determined in the sole judgment of a student conduct administrator (SCA), to be appropriate.

5. The SCA shall render the decision to the respondent and the complainant simultaneously and in writing within five business days. The *Student Code of Conduct* provides for the disclosure to the complainant of the final results of any disciplinary proceeding regarding a complaint of domestic violence, dating violence, sexual assault, or stalking.

6. Decisions may be appealed by both parties in accordance with the *Student Code of Conduct,* as applicable. All parties will be informed in writing of the outcome of any appeal.

The standard of proof that exists for campus disciplinary proceedings is preponderance of evidence, (i.e., more likely than not the event(s) occurred). A student's privacy concerns are weighed against the needs of the College to respond to certain incidents and crimes. To the greatest extent possible, all reports will remain private. However, information may be shared with appropriate departments and agencies under a need-toknow basis when it pertains to investigative needs and safety concerns of the campus community.

Faculty and Staff

If a faculty or staff member is involved as the complainant or respondent:

1. All incidents are to be reported to the Title IX coordinator.

2. Based on the initial report of the incident, the Title IX coordinator, with assistance from BCCPD, Human Resources and/or Vice President of Student Success Office, will implement any temporary safety measures immediately.

3. The Title IX coordinator will then assign a Title IX investigator or investigators to investigate the incident.

4. The Title IX investigator(s) will investigate the incident and submit a final written report to the Title IX coordinator.

5. If it is determined that discipline or dismissal of a faculty or staff member is warranted the Department supervisor and or Human Resources will follow the Progressive Discipline as outlined in College Regulation 3.9009R.

6. Both the complainant and respondent will be notified in writing of the final results of the investigation and any resulting actions.

7. Both the complainant and respondent may appeal the final determination pursuant to the College's appeal procedures.

The standard of proof that exists for campus disciplinary proceedings is preponderance of evidence, (i.e., more likely than not the event(s) occurred). If a complainant requests that his or her name not be revealed to the respondent or asks the College not to investigate or seek action against the respondent, the College will be limited in its ability to respond fully to the incident.

Interim Arrangements and Post-Hearing Interventions

Brookdale Community College actively provides services for all parties in domestic violence, dating violence, sexual assault, and stalking cases. The College continues a coordinated response system that attends to the complainant's and respondent's physical and emotional well-being as well as the safety of the community.

Administrative Services to Assist a Student Complainant or Respondent

The Vice President of Student Success Office (VPOS) will assist students, including collaborating with BCCPD and other departments to provide:

1. Referral to a counselor at the Brookdale Counseling Center (BCC), or referrals to outside provider(s). (Counseling Center)

2. Escort services. (BCCPD)

3. Assistance in petitioning for a protection order. BCCPD honors orders of protection, no-contact orders, restraining orders, or similar orders issued by a criminal, civil, or tribal court. (BCCPD)

4. Withdrawal from the College. (VPOS)

5. An on-campus investigation and, if appropriate, initiate on-campus disciplinary procedures. (VPOS)

6. Other referrals as necessary.

Administrative Services to Assist Faculty or Staff Complainant or Respondent

The Title IX coordinator will assist faculty and staff, including collaborating with BCCPD and other departments to provide:

1. Referral to the Employee Assistance Program.

2. Escort services. (BCCPD)

3. Assistance in petitioning for a protection order. BCCPD honors orders of protection, no-contact orders, restraining orders, or similar orders issued by a criminal, civil, or tribal court. (BCCPD)

4. Conduct an on-campus investigation and, if appropriate, initiate disciplinary/dismissal procedures. (Title IX Coordinator and/or Human Resources)

5. Other referrals as necessary.

Interim Conditions and Post-Hearing Interventions Applying to Complainants and Respondents

1. The complainant and/or respondent may have parking re-assigned.

2. The complainant and/or respondent may have his/her academic schedule altered and/or arrangements with instructors to assist in offsetting potential academic problems will be coordinated. This service is not applicable for a respondent who has been temporarily or immediately removed from campus and/or classes.

3. The respondent may be directed not to have contact, by any means, with a complainant.

4. The complainant may be directed not to have contact, by any means, with a respondent.

5 Any individual who is alleged to have committed a violent act, including domestic violence, dating violence, sexual assault, or stalking upon a member of the campus community, may be banned from campus and campus activities.

6. Other conditions as deemed appropriate.

Defining Acts Involved with Sex Offenses

The following state definitions are informational and are not used to classify crime statistics in the Annual Security Report.

SEXUAL ASSAULT Any conduct proscribed by N.J.S.A. 2C:14-2a (1) through (7), N.J.S.A. 2C:14-2b, N.J.S.A. 2C:14-2c (1) through (4), and N.J.S.A. 2C:14-3a. and b. of the New Jersey Code of Criminal Justice, including any act of sexual contact or penetration performed or perpetrated on one person by another without mutual consent, or with an inability of one party to consent due to age, mental defect or physical incapacitation. In 1979, the terms "rape," "sodomy," and "carnal knowledge" were replaced in the New Jersey Criminal Code with the term "sexual assault." Therefore, these Standards will use the term "sexual assault" exclusively when referring to the criminal acts as described in Title 2C, Chapter 14.

SEXUAL OFFENSES - N.J.S.A. 2C:14-2 Sexual assault a. An actor is guilty of aggravated sexual assault if he commits an act of sexual penetration with another person under any one of the following circumstances: (1) The victim is less than 13 years old; (2) The victim is at least 13 but less than 16 years old; and (a) The actor is related to the victim by blood or affinity to the third degree, or (b) The actor has supervisory or disciplinary power over the victim by virtue of the actor's legal, professional, or occupational status, or (c) The actor is a resource family parent, a guardian, or stands in loco parentis within the household; (3) The act is committed during the commission, or attempted commission, whether alone or with one or more other persons, of robbery, kidnaping, homicide, aggravated assault on another, burglary, arson or criminal escape; (4) The actor is armed with a weapon or any object fashioned in such a manner as to lead the victim to reasonably believe it to be a weapon and threatens by word or gesture to use the weapon or object; (5) The actor is aided or abetted by one or more other persons and the actor uses physical force or coercion; (6) The actor uses physical force or coercion and severe personal injury is sustained by the victim; (7) The victim is one whom the actor knew or should have known was physically helpless, mentally defective or mentally incapacitated. Aggravated sexual assault is a crime of the first degree. b. An actor is guilty of sexual assault if he commits an act of sexual contact with a victim who is less than 13 years old and the actor is at least four years older than the victim. c. An actor is quilty of sexual assault if he commits an act of sexual penetration with another person under any one of the following circumstances: (1) The actor uses physical force or coercion, but the victim does not sustain severe personal injury; (2) The victim is on probation or parole, or is detained in a hospital, prison or other institution and the actor has supervisory or disciplinary power over the victim by virtue of the actor's legal, professional or occupational status; (3) The victim is at least 16 but less than 18 years old and: (a) The actor is related to the victim by blood or affinity to the third degree; or (b) The actor has supervisory or disciplinary power of any nature or in any capacity over the victim; or (c) The actor is a resource family parent, a guardian, or stands in loco parentis within the household; (4) The victim is at least 13 but less than 16 years old and the actor is at least four years older than the victim. Sexual assault is a crime of the second degree.

N.J.S.A. 2C:14-3. Criminal sexual contact a. An actor is guilty of aggravated criminal sexual contact if he commits an act of sexual contact with the victim under any of the circumstances set forth in 2C:14-2a. (2) through (7). Aggravated criminal sexual contact is a crime of the third degree, b. An actor is guilty of criminal sexual contact if he commits an act of sexual contact with the victim under any of the circumstances set forth in section 2C:14-2c. (1) through (4). Criminal sexual contact is a crime of the fourth degree. (2) The victim is at least 13 but less than 16 years old; and (a) The actor is related to the victim by blood or affinity to the third degree, or (b) The actor has supervisory or disciplinary power over the victim by virtue of the actor's legal, professional, or occupational status, or (c) The actor is a resource family parent, a guardian, or stands in loco parentis within the household; (3) The act is committed during the commission, or attempted commission, whether alone or with one or more other persons, of robbery, kidnaping, homicide, aggravated assault on another, burglary, arson or criminal escape; (4) The actor is armed with a weapon or any object fashioned in such a manner as to lead the victim to reasonably believe it to be a weapon and threatens by word or gesture to use the weapon or object: (5) The actor is aided or abetted by one or more other persons and the actor uses physical force or coercion; (6) The actor uses physical force or coercion and severe personal injury is sustained by the victim: (7) The victim is one whom the actor knew or should have mentally known was physically helpless, defective or mentally incapacitated. Aggravated sexual assault is a crime of the first degree. b. An actor is guilty of sexual assault if he commits an act of sexual contact with a victim who is less than 13 years old and the actor is at least four years older than the victim. c. An actor is guilty of sexual assault if he commits an act of sexual penetration with another person under any one of the following circumstances: (1) The actor uses physical force or coercion, but the victim does not sustain severe personal injury; (2) The victim is on probation or parole, or is detained in a hospital, prison or other institution and the actor has supervisory or disciplinary power over the victim by virtue of the actor's legal, professional or occupational status; (3) The victim is at least 16 but less than 18 years old and: (a) The actor is related to the victim by blood or affinity to the third degree; or (b) The actor has supervisory or disciplinary power of any nature or in any capacity over the victim; or (c) The actor is a resource family parent, a guardian, or stands in loco parentis within the household; (4) The victim is at least 13

but less than 16 years old and the actor is at least four years older than the victim. Sexual assault is a crime of the second degree.

N.J.S.A. 2C:14-4 Lewdness a. A person commits a disorderly persons offense if he does any flagrantly lewd and offensive act which he knows or reasonably expects is likely to be observed by other non-consenting persons who would be affronted or alarmed. b. A person commits a crime of the fourth degree if: (1) He exposes his intimate parts for the purpose of arousing or gratifying the sexual desire of the actor or of any other person under circumstances where the actor knows or reasonably expects he is likely to be observed by a child who is less than 13 years of age where the actor is at least four years older than the child. (2) He exposes his intimate parts for the purpose of arousing or gratifying the sexual desire of the actor or of any other person under circumstances where the actor knows or reasonably expects he is likely to be observed by a person who because of mental disease or defect is unable to understand the sexual nature of the actor's conduct. c. As used in this section: "lewd acts" shall include the exposing of the genitals for the purpose of arousing or gratifying the sexual desire of the actor or of any other person.

Domestic Violence. A. Domestic Violence means the occurrence of one or more of the following criminal offenses upon a person protected under the Prevention of Domestic Violence Act of 1990: Homicide N.J.S.A. 2C:11-1 Assault N.J.S.A. 2C:12-1 Terroristic threats N.J.S.A. 2C:12-3 Kidnapping N.J.S.A. 2C:13-1 Criminal restraint N.J.S.A. 2C:13-2 False imprisonment N.J.S.A. 2C:13-3 Sexual assault N.J.S.A. 2C:14-2 Criminal sexual contact. N.J.S.A. 2C:14-3 Lewdness N.J.S.A. 2C:14-4 Criminal mischief. N.J.S.A. 2C:17-3 Burglary N.J.S.A. 2C:18-2 Criminal trespass N.J.S.A. 2C:18-3 Harassment N.J.S.A. 2C:33-4 Stalking N.J.S.A. 2C:12-10 B. Victim of Domestic Violence means a person protected by the domestic violence act and includes any person: 1. who is 18 years of age or older, or 2. who is an emancipated minor, and who has been subjected to domestic violence by: a. spouse b. former spouse c. any other person who is a present or former household member, OR 3. who, regardless of age, has been subjected to domestic violence by a person: a. with whom the victim has a child in common, or b. with whom the victim anticipates having a child in common, if one of the parties is pregnant, or 4. who, regardless of age, has been subjected to domestic violence by a person with whom the victim has had a dating relationship. a. Stalking,

2C:12-10. **Definitions; stalking designated a crime; degrees.** a. As used in this act: (1) "Course of conduct" means repeatedly maintaining a visual or physical proximity to a person; directly, indirectly, or through third parties, by any action, method, device, or means, monitorina. observina. surveillina. followina. threatening. or communicating to or about, a person, or interfering with a person's property; repeatedly committing harassment against a person; or repeatedly conveying, or causing to be conveyed, verbal or written threats or threats conveyed by any other means of communication or threats implied by conduct or a combination thereof directed at or toward a person. (2) "Repeatedly" means on two or more occasions. (3) "Emotional distress" means significant mental suffering or distress. (4) "Cause a reasonable person to fear" means to cause fear which a reasonable victim, similarly situated, would have under the circumstances, b. A person is guilty of stalking, a crime of the fourth degree, if he purposefully or knowingly engages in a course of conduct directed at a specific person that would cause a reasonable person to fear for his safety or the safety of a third person or suffer other emotional distress. c. A person is guilty of a crime of the third degree if he commits the crime of stalking in violation of an existing court order prohibiting the behavior. d. A person who commits a second or subsequent offense of stalking against the same victim is guilty of a crime of the third degree. e. A person is guilty of a crime of the third degree if he commits the crime of stalking while serving a term of imprisonment or while on parole or probation as the result of a conviction for any indictable offense under the laws of this State, any other state or the United States. f. This act shall not apply to conduct which occurs during organized group picketing.

Access to Campus Facilities at Lincroft

The Lincroft Campus is open to the public. The Newman Springs Road and the Phalanx Road entrances are not gated but the College grounds and buildings should only be accessed/occupied during established business hours, which are typically 6:00AM until 11:00PM Monday through Friday, until 4:00 PM on Saturday, and until 1:00PM on Sundays, in accordance with the policies established by the Campus administration. The Buildings are typically secured during those hours when the College is closed. The schedules for these buildings fluctuate and are available from the Brookdale website. The Library hours fluctuate throughout the year, so it is best to check the Library schedule to determine the operating hours.

Maintenance of Campus Facilities

Facilities and landscaping are maintained in a manner that minimizes hazardous conditions. BCCPD police officers and security officers regularly patrol the Brookdale properties and report on malfunctioning lights and other unsafe physical conditions to Facilities Management for correction. Other members of the College community are helpful when they report equipment problems to BCCPD or to Facilities Management.

Public Relations/Crime Information Review

Representatives from the *Brookdale Newsroom*, a student online news site and *90.5 The Night*, the campus radio station, are invited to meet with the BCCPD Police Chief or a designee on a regular basis to discuss crime on campus, and they decide what information they want to report to the College community. A daily crime log is available for review 24/7 in the BCCPD building located in Parking lot 8. The information in the crime log typically includes the case number, classification, date reported, date occurred, time occurred, general location, and disposition of each crime

As required by the Jeanne Clery Disclosure of Campus Security Policy and Crime Statistics Act each year Brookdale Community College publishes an Annual Security Report on its website. Within this Annual Security Report [ASR], are all of the reported crimes from the prior calendar year that occurred on/reasonably contiguous to each of Brookdale's properties/campuses/regional centers.

In addition to crime statistics, this ASR also includes information on crime prevention, how to get in contact with the Brookdale Police Department, Student Conduct, safety issues, and Timely Warnings and Emergency Notifications/Brookdale's emergency notification systems.

Brookdale Community College Overview and Background:

B rookdale Community College (BCC) recently, celebrated its 50th anniversary. The Lincroft Campus is located in the Lincroft section of Middletown Township in the center of Monmouth County just minutes from the Parkway exit 109. (BCC) is an excellent resource for residents of Monmouth County, New Jersey. Brookdale offers AA, AFA, AS, and AAS degrees in 75 academic programs including options, 7 Academic Credit Certificates, and 11 Academic Credit Certificates of Achievement., plus noncredit classes in many areas of personal and professional interest.

The College was founded in 1967 and is sponsored by the citizens of Monmouth County through the Board of Chosen Freeholders. Equal opportunity for all is a College mandate; the College does not discriminate against anyone on any basis, either in education or in employment practices. An appointed Board of Trustees sets policies, fixes tuition and fees and continually monitors education programs.

Our credit enrollment in Fall 2021 was 9,566 full and part time students. Brookdale Community College does not provide dormitories/student housing for its students.

Most Brookdale students are eligible for various forms of Financial Aid administered through the College, including federal and state grants and loans, and private scholarships offered through the Brookdale Foundation.

All students are encouraged to participate in the many campus events, clubs, guest lectures and athletic programs offered through the office of Student Life & Activities. Brookdale also provides a wide range of Student Services including Cooperative Education, Work-Study, Paid and Unpaid Internships, Experiential and Service-Learning, Graduate Placement, and Services for Persons with Disabilities.

Brookdale also operates Regional locations around Monmouth County, offering local access to Brookdale's credit and non-credit programs and services, as well as contributing to the economic growth of Monmouth County.

In the over 50 years since Brookdale opened its doors, both the College and the County have grown tremendously. The 220-acre main campus in Lincroft today comprises 22 buildings totaling 731,353 square feet, including Larrison Hall, the Center for the Visual Arts, the Bankier Library, and the Warner Student Life Center and our beautiful Fitness Center and Recreation & Events Center. The campus also includes a 380-seat Performing Arts Center, an Advanced Technology Center with state-of-the art television and electronic music studios, 10 athletic fields, Brookdale public radio 90.5 The Night, and some 60 computer labs with about 1,600 fully networked PCs running all today's mainstream applications.

The Monmouth Museum is also located on the Brookdale campus.

Brookdale is an open admission, comprehensive community college, available to anyone 18 years of age or older, anyone who is a high school graduate or holder of an equivalency diploma. If you do not have a high school diploma or an equivalency diploma, you may still enroll at Brookdale as long as you are 18 or older.

The Lincroft Campus is in a quiet, residential neighborhood. The College enjoys a student, faculty, and staff population of nearly 20,000 individuals, plus a significant number of visitors to BCC's many programs and special events.

The College campuses are some of the safest in the country, but no campus is free from crime, whether it is urban, suburban, or rural. All members of the College community, therefore, should take reasonable precautions. BCC is committed to working with all members of the community to make our campuses safe and secure environments. The College has developed a series of policies and procedures to assist in these efforts.

The following information has been prepared to increase your awareness of the current programs that exist to assist you in protecting your safety and well-being. Portions are also provided in compliance with federal law, specifically the Clery Act and the Higher Education Opportunity Act (HEOA). BCC has been fortunate in experiencing few serious crimes, but such incidents could occur, and all crime is serious to the victim. Students, Faculty, and Staff are responsible for adopting measures to protect themselves and their possessions.

The information contained on pages 1 through 91 of this brochure pertains to the Lincroft Campus as well as Brookdale at Hazlet, Brookdale at Long Branch, Brookdale at Wall, Brookdale at Neptune and Brookdale at Freehold. Since students regularly use all campuses, the compliance information for all campuses has been combined into one section of this document so that all BCC students receive security information and crime statistics for all campuses.

The Brookdale Community College Police Department

The Brookdale Community College Police Department (BCCPD) is an accredited police department responsible for providing police and security services for the Lincroft campus. The Brookdale Community College Police Department is also responsible for providing security officer personnel at our Regional locations in Hazlet, Long Branch, Wall, Neptune and Freehold campuses

On the **Lincroft** Campus, BCCPD is located at: 765 Newman Springs Rd, Lincroft NJ, on Alumni Drive.

On the Regional locations, a security officer is posted just inside the main front doors.

Brookdale at Hazlet is located at:

One Crown Plaza, Hazlet, NJ just off Union Ave. between Route 35 and Route 516.

Brookdale at Long Branch is located at:

On the corner of Broadway and Third Ave., Long Branch, NJ just off the Parkway exit 105 and Route 36 east.

Brookdale at Wall is located at:

On Monmouth Boulevard at 6th street, Wall, NJ just off Union Ave. just off of Route 18.

Brookdale at Neptune is located at:

60 Neptune Boulevard, Neptune, NJ just west of Route 35.

Brookdale at Freehold is located at:

3680 Route 9 South, Freehold, NJ just south of Route 33.

BCCPD is headed by a Police Chief who reports to the Associate Vice President-Human Resources & Organizational Safety. There are 12 Fulltime sworn Police Officers certified by the PTC and the State of New Jersey. BCCPD received a 3-year NJSACOP Re-Accreditation in June 2019. The BCCPD operates twenty-four hours a day, 365 days a year. It is a unique law enforcement agency designed specifically to serve the needs of the College community. BCC Police Officers receive the same police academy training and have the same authority as any New Jersey municipal police officers. They have full arrest powers and enforce traffic and criminal statutes as well as College policies and regulations. BCC Police maintain mobile, bicycle, and foot patrols that cover the entire Lincroft campus. They are always in radio contact with each other and the Monmouth County Sheriff's Office Communications Center and quickly respond to and report on potentially unsafe conditions/situations and or emergency situations and calls for assistance. BCCPD Police Officers are trained in first aid, NARCAN[®] and CPR, and on to use Automated External Defibrillators [AEDs] and tourniquets. BCCPD Police Officers are part of the BCC Behavioral Review Team and they offer up public education programs/speeches on personal safety/sexual assault prevention, distracted driving, emergency management, and other topics. The BCCPD Officers also partake in charitable events.

Security Officers are on duty during times that classes are in session and maintain security at all of our Regional locations, i.e. Hazlet, Long Branch, Wall, Neptune and Freehold. They are uniformed and remain visible at all times, and write formal reports on incidents, including potentially unsafe conditions/situations. These Security Officers do not have police powers but are available in case of need and will contact the related municipal department for any problems that require police action. They are supervised by the BCC Police Department and all BCC regulations apply. The security officers are also trained in CPR, AED and tourniquets.

Both Brookdale Security Officers and Brookdale Police Officers complete Incident Reports to the College's Student Judicial and Conduct department whenever issues arise related to Student Conduct Violations and Concerning Student Behavior. Training

BCCPD employs specialized ongoing training for its police officers Training subjects include Firearms Training, Active Shooter Training, Deescalation Training, critical incident response, and all facets of protection of persons and property. Training also includes lectures/classes that are presented by the Monmouth County Prosecutors Office and other outside local, County, State and Federal law enforcement agencies, as well as private entities. Training is also conducted for police and security officers via online modules and during internal meetings/training sessions. Training topics may pertain to existing problems, new court decisions impacting the College environment, and other timely topics.

Mission Statement

BCCPD is dedicated to developing partnerships with the community we serve, including students, staff, and faculty in order to enhance the goal of providing quality higher education in a safe and secure atmosphere. Through these partnerships, we will preserve a learning environment that supports academic freedom, respect for diversity, fair and equal treatment to all, and an open exchange of ideas.

Campus Safety Equipment and Enhancements:

- The Brookdale properties have a total of 28 'Blue Light' Emergency telephones in place.
- Brookdale has a total of 17 Automated External Defibrillators on its properties.
- Each police officer and security officer have access to first aid equipment and tourniquets.
- A total of 172 security cameras are installed across the Brookdale properties.
- Brookdale maintains a full fire alert and suppression system in each of its buildings, on each of its properties.
- Brookdale's Police Department utilizes 7 total police cars/SUVs to patrol grounds and to respond to emergencies.
- The Brookdale Police Department maintains specialized tactical equipment, and partakes in specialized tactical training, to prepare for and help prevent a mass incident.

Criminal Investigations and Working Relationships with Other Law Enforcement Agencies

The BCC Police Department maintains a close working relationship with the Middletown Township Police Department (MTPD). The BCCPD staff occasionally works with other law enforcement agencies in the towns, in which the Regional locations are located, as well as the FBI and the U.S. Secret Service. Meetings are held between the leaders of these agencies on both a formal and informal basis. The officers of BCCPD and MTPD communicate regularly on the scene of incidents that occur in and around the campus area. The BCCPD investigates all crimes that were reported to have occurred on the Lincroft campus, and they document all investigative actions through written standardized Incident Reports and other documents. The BCCPD also works closely with the investigative staff at MTPD and the Monmouth County Prosecutors Office, as well as other local Police Departments when incidents arise that require joint investigative efforts, resources, crime related reports and exchanges of information, as deemed necessary. The BCCPD Security Officers complete Daily Activity Reports to document their actions and activities. They complete standardized Incident Reports for significant incidents, including all crimes. The Security Officers report all criminal activities and emergency situations to the local municipal police department of that facility, if such a report has not yet been made.

Student Conduct Violations, Investigations and Sanctions

All Brookdale students are supplied with a copy of the Brookdale Community College Student Handbook as part of each semester's registration process. Investigations of alleged student code of conduct violations at any of Brookdale locations are overseen and investigated by the Director of Student Conduct and Compliance, who can be reached at (732)-224-2096.

If ever a student has committed an act which is so serious, or has been deemed to be an immediate threat against the College community, the Director of Student Conduct and Compliance is empowered to, and may determine that, an immediate suspension/banning of the person from any/all Brookdale grounds is justified.

The Director of Student Conduct and Compliance may impose one or more sanctions as described below for violations of the *Student Code of Conduct.*

Status Sanctions

The following sanctions may be applied either singularly or in any combination as appropriate to the circumstances of each case:

- 1. Verbal Reprimand: Verbal admonition against further violations.
- 2. Written Reprimand: Written warning placed in student's file for having engaged in misconduct.
- 3. **Restitution:** The obligation to replace or pay for property damaged to compensate for losses incurred or to provide a campus service as a result of a violation.
- 4. **Conditional Probation:** Temporary loss of College rights and privileges until specified conditions are met, such as letters of apology, and/or doctor's releases, etc.
- 5. **Disciplinary Probation:** Loss of participation in College-related activities for a specified period of time. May also contain conditions to be met in order to be removed from probation.
- 6. Fine: Monetary sum imposed as a penalty for an offense.
- 7. **Community Service:** Assigned community service work to fit a particular violation.
- 8. **Suspension:** Exclusion from all or specified classes and other College-related activities for a specified period of time.
- 9. **Expulsion:** Permanent dismissal from classes and college related activities.
- 10. Summary (Temporary) Suspension: Exclusion for all or specified classes and other College-related activities until due process can be completed. May be used by the Vice President of Student Success in the event of a threat of safety to the student or College community or if a student refuses to respond to a summons to appear before the Director of Student Conduct & Compliance or his/her designee.

Reporting Procedures General Procedures for Reporting a Crime or other related incidents:

Community members, students, faculty, staff, and guests are encouraged to report all crimes and public safety-related incidents to BCCPD or a Campus Security Authority in a timely manner. This publication focuses on BCCPD because it patrols the Lincroft Campus. However, Security should be contacted when incidents, emergencies, or crimes occur at the Regional locations.

To report an emergency call 9-1-1 from a Brookdale internal phone, or 9-1-1 from a cell phone. To report a Crime or other incident call BCCPD at extension 2222 on the **Lincroft** Campus. You may also come to the Brookdale Police Department Headquarters, located on Alumni Dr. off of Campus Dr., near the Rt. 520 entrance to the College. From outside the College phone system call, (732) 224-2222 to also report a nonemergency security or public safety-related matter.

To report an emergency at the Hazlet regional location, call 9-1-1 from a Brookdale internal phone, or 9-1-1 from a cell phone. To report a nonemergency at the **Hazlet** regional location, call Security at 4004, go to the Security Desk [at the front entrance] or call from outside the College phone system, (732) 739-6012

To report an emergency at the Long Branch regional location, call 9-1-1 from a Brookdale internal phone, or 9-1-1 from a cell phone. To report a non-emergency at the **Long Branch** regional location, call Security at 1514, go to the Security Desk [at the front entrance], or call from outside the College phone system, (732) 229-8440 ext. #1

To report an emergency at the Wall Campus, call 9-1-1 from a Brookdale internal phone, or 9-1-1 from a cell phone. To report a non-emergency at the **Wall** Campus, call Security at 6001 go to the Security Desk [at the West/Main entrance] or call from outside the College phone system, (732) 280-7090 ext. #1.

To report an emergency at the Neptune regional location, call 9-1-1 from a Brookdale internal phone, or 9-1-1 from a cell phone. To report a nonemergency at the **Neptune** regional location, call Security at 1226, go to the Security Desk [at the front entrance] or call from outside the College phone system, (732) 774-3363 ext. #1.

To report an emergency at the Freehold Campus, call 9-1-1 from a Brookdale internal phone, or 9-1-1 from a cell phone. To report a nonemergency at the **Freehold** Campus, call Security at 7000, go to the Security Desk [at the front entrance] or call from outside the College phone system, (732) 625-7000.

Dispatchers/Communications

Dispatchers are available from the Lincroft campus telephone numbers 24 hours a day to answer your calls. In response to a call, BCCPD will take the required action, either by dispatching a police officer or security officer to the scene or by asking the victim to report to BCCPD to file an incident report.

Confidential Reporting Procedures

If you are the victim of a crime and do not want to pursue action within the College system or the criminal justice system, you may still want to consider making a confidential report. With your permission, a BCCPD officer or an official from the Office of Student Judicial Affairs can file a report on the details of the incident without revealing your identity. The purpose of a confidential report is to comply with your wish to keep the matter confidential, while taking steps to ensure the future safety of yourself and others. With such information, the College can keep an accurate record of the number of incidents involving students, employees and visitors; determine where there is a pattern of crime with regard to a particular location, method, or assailant; and alert the campus community to potential danger. Reports filed in this manner are counted and disclosed in the annual crime statistics for the institution.

TIPS Line

BCCPD operates a "TIPS" line to allow people to anonymously report security and safety related concerns and to provide BCCPD with "tips" about criminal incidents or behavior on campus. On campus dial 1999 or outside Campus (732) 224-1999 to reach this recorded line. The TIPS line is monitored by the BCCPD.

Campus Security Authorities

Campus Security Authorities [CSAs] are individuals who, because of their job function, have a responsibility under the Clery law to notify the College of alleged 'Clery Crimes [as defined and listed later in this document]' that they witnessed, or which were reported to them by a student or other. These CSAs are typically people who have some responsibility for campus security/safety, or who are involved with matters like student activities/athletics and student discipline or advising. Brookdale CSAs include but are not limited to the Brookdale Community College Police Officers, Security Officers, Athletic Directors and Coaches, Student Life Employees and Advisors, and the Title IX Coordinators.

Investigative actions

Some BCCPD incident reports are forwarded to the Dean of Students Office for review and referral to the Office of Student Judicial Affairs for potential action, as appropriate, BCCPD Investigators will investigate a report when it is deemed appropriate. Additional information obtained via the investigation may also be forwarded to the Office of Student Judicial Affairs. If assistance is required from the Middletown Township Police Department, the Prosecutors office or the Fire Department, BCCPD will contact the appropriate unit. If a sexual assault or rape should occur, staff on the scene, including BCCPD, will offer the victim a wide variety of services. BCCPD will contact the Monmouth County Radio Room who activates the Sexual Assault Response Team (SART). They have trained members who are on-call and available to assist a victim of sexual assault 24 hours a day. This publication contains information about on- and offcampus resources and is made available to all BCC community members. The information about "resources" is not provided to infer that those resources are "crime reporting entities" for BCC. Crimes should be reported to the Brookdale Police Department or to a CSA to ensure inclusion in the annual crime statistics and to aid in providing timely warning notices to the community, when appropriate. For example, a crime that was reported only to the Rape Crisis Center would not be included in the BCC crime statistics. BCCPD sends a request each year to the College Counseling Center that encourages the counselors to inform the persons they are counseling of the procedures to report crimes on a voluntary, confidential basis for inclusion in the annual disclosure of crime statistics, when they deem it appropriate.

Timely Warning Notifications to the BCC Community about Reported Clery Crimes

In an effort to provide timely notice to the BCC community in the event of a reported serious crime [on or off campus], which may pose a serious and ongoing threat to members of the BCC community, a Timely Warning/Crime Alert shall be sent out to the Brookdale community. Timely Warnings are required to contain certain information, including a description of the crime that has been reported, and information that pertain to the alleged crime's location. The Timely Warning will also include information on how to help one prevent being a victim of a future similar crime, as such prevention and the making of informed decisions is the main purpose of such Warnings. The confidentiality/anonymity of the victim is paramount. The Timely Warnings are issued by the Brookdale Community College Chief of Police or a designee and are distributed to the Brookdale community by means of text messages, voice over messages, desktop computers alerts, broadcast emails, social media posts and website postings as appropriate for the particular emergency. The College employs "Informacast" to send out these messages. Broadcast emails go out to all who have Brookdalecc.edu email addresses, which includes employees and non-students. Updates to the BCC community about any particular case resulting in a Timely Warning may be distributed via the same electronic means as the original Timely Warnings. Crime Alert posters may also be posted by BCCPD in campus buildings or at the BCCPD Headquarters when deemed necessary. When crime alerts are posted in campus buildings, they are posted in a discernible way in the lobby/entrance area of the affected building(s) for at least seven days.

Timely Warnings are distributed to the Brookdale community when there is a serious or ongoing threat to the Brookdale community, the crime reported was:

1] Arson, 2] Murder/Manslaughter, 3] Robbery, 4] Aggravated assault, 5] Sex offenses, 6] Burglary 7] Weapons, with intent to use 8] Hate Crimes 9] Any other crime classifications, as may be necessary.

It is noted that this Annual Security Report documents crimes that were <u>reported</u> to have occurred at/around Brookdale's properties<u>, not those that</u> <u>were proven to have occurred</u>. Likewise, Timely Warnings will be issued for crimes that were <u>reported</u>, <u>not those that have been proven</u> to have occurred.

Since the criteria for a Timely Warning includes crimes that present a <u>serious and ongoing threat to the community, not all reported crimes within</u> <u>these categories will necessitate the issuance of a Timely Warning</u>. The incidents and need for a Timely Warning are assessed on a case-by-case basis by the Brookdale Chief of Police/designee and depending on the facts of the case and the information known by BCCPD. For example, if an assault occurs between two students who have a disagreement, or if an arrest has been made for a robbery, there may be no on-going threat to other BCC community members, and thus, a Timely Warning/Crime Alert would not be distributed.

Emergency Notifications

Emergency Notifications are made by the College when there has been confirmation that an emergency or dangerous situation exists and presents itself as an immediate threat to the health or safety of the community at a particular Brookdale property, or in a particular portion of a property.

The BCCPD and the Monmouth County Sheriff's Office Communications Center [MCSCC], outside law enforcement agencies and others receive information about situations or emergencies that may present themselves as an immediate or ongoing threat to the Brookdale community, at one or more locations. Those entities are notified to advise the BCCPD of any such condition, so that we may alert our community, via an Emergency Notification or Timely Warning. Various offices/departments on campus, such as the Counseling Department and Facilities, also may receive such concerning information.

If BCCPD confirms that there is an emergency or dangerous situation that poses an immediate threat to the health or safety of some or all members of the BCC community, the Police Chief/Officer/designee will authorize the issuance without delay, determine the content of the message, and will use some or all of the systems described below to communicate the threat to the BCC community or to the appropriate segment of the community.

If the threat is limited to a particular building or segment of the population, the Chief of Police or OIC and College Relations Department will, without delay, and taking into account the safety of the community, determine the content of the notification and initiate the notification system, unless issuing a notification will, in the judgment of the first responders (including, but not limited to: BCCPD, MTPD, and/or the Fire and Emergency Medical Services), compromise the efforts to assist a victim or to contain, respond to, or otherwise mitigate the emergency.

Emergency Notifications will be sent out to the community via the emergency messaging [Informacast] system, including emergency text messages, voice/phone messages over Brookdale's internal phones, broadcast emails, desktop alerts, social media posts and website postings, as appropriate for the particular emergency. If the circumstances dictate the need, the Brookdale Police or Security Officers or other employees may make notification in person, via foot or via vehicle patrols.

Unlike Timely Warnings, Emergency Notifications can be made for reasons other than crimes, like a fire/concern, an approaching tornado, or another manmade or naturally hazardous condition. There may be occasions where a situation can be classified as both an ongoing criminal threat and an immediate threat to the health/safety of the community, and in those cases, either an Emergency Notification or a Timely Warning will be sent out.

The College will post updates during a critical incident the emergency text messaging system, via broadcast emails, and/or via the BCC website. Individuals may be advised to call a BCC recorded information telephone line for updates. Members of the larger community who are interested in receiving information about emergencies on campus should sign up for the emergency text message system and should use the Brookdale website and the (732) 842-1900 line for obtaining updates in the event of an emergency on campus.

BCC community members are encouraged to notify BCCPD of any situation or incident on campus that involves a significant emergency or dangerous situation that may involve an immediate or ongoing threat to the health and safety of students and/or employees on campus. BCCPD has the responsibility of responding to, and summoning the necessary resources, to mitigate, investigate, and document any situation that may cause a significant emergency or dangerous situation. In addition, BCCPD has a responsibility to respond to such incidents to determine if the situation does in fact, pose a threat to the community. If so, federal law requires that the institution notify the campus community or the appropriate segments of the community that may be affected by the situation

Statistical Disclosure of Clery Crimes/Reported Incidents


