### II. Mission/Vision/Value

a. ALPFA is the premier business organization for expanding opportunities for Latino leadership in the global market. ALPFA creates opportunities, adds value, and builds relationships for its members, the community and its business partners while expanding Latino leadership in the global workforce. Some of the things that we value most are professional growth, integrity, culture, relationship building, service, inclusiveness and teamwork. As a Brookdale organization our purpose is to promote the Alpha Organization's mission and to create an environment that is conducive to the growth of students who wish to excel in any field of business.

## III. Membership:

a. Membership in the Brookdale ALPFA Chapter will have to pay 20 dollars unless told otherwise by the president, our New Jersey Chapter, or National. All members must be majoring in business related majors. All business majors are accepted. Members must also meet the minimum 3.2 GPA requirement. ALPFA is a Latino organization however we do not limit ALPFA to only Latinos. ALPFA is opened to all race, color, gender, sexual orientation, or political, ethnic, or religious persons that meet the GPA requirement.

### IV. Executive Board:

- a. ALPFA will have six executive board members a Chief Executive Officer (CEO), Chief Financial Officer (CFO), Chief Operating Officer (COO), Chief Information Office (CIO), Chief Marketing Officer (CMO), and a Chief Networking Officer (CNO). Students that serve on the executive committee must be enrolled for at least six (6) college credits at Brookdale Community College.
- Elections will be held at the end of every academic school year. All nominations
  will be made at the meeting prior to the election, with notification of those
  nominations being sent to all members prior to the election meeting.
   Nomination may be re-opened by majority vote.

- 2. Responsible for managing:
  - a. financial budgets
  - b. deposits
  - c. record keeping/bookkeeping
  - d. Depositing money into our chapter account
  - e. Responsible for reporting financial data to the CEO
- iv. Chief Information Officer (CIO):
  - 1. Maintain chapter's website/ Facebook page/twitter
  - Giving out contact information (If needed) to officers, advisor(s), or members
  - Responsible for emailing officers, advisor(s), and members on upcoming events that we are attending and holding.
- v. Chief Operating Officer (COO):
  - 1. Coordinating events, meetings, and fundraisers
- vi. Chief Marking Officer (CMO):
  - Responsible for advertising our fundraisers and events around Brookdale.

- vii. Chief Networking Officer (CNO):
  - Responsible for networking events for the chapter and making sure everyone has RSVP their spot in the event that we are attaining.
  - Responsible for gathering all the information about the networking event

### d. Vacancies

i. In the event that one of our officers leaves in the middle of the academic school year. An interim officer will be appointed by the leaving officer and approved by the executive board and advisors. Also, in the event that one of the officers is impeached or unable to appoint an interim officer then the president will appoint an officer for approval.

### V. Frequency of meetings

a. There will be two meetings held in each week within the fall and spring semester. One meeting will be held for all members in our chapter. The other will be held for officers on the board. Also, if needed more meetings can be added.

### VI. Quorum

a. All members must attained 10 out of the 15 meetings during each fall and spring semester. In order to transact formal business twenty five percent(25%) of members must be in attendance at the member meetings each week.

a. All monies of organizations shall be kept in special account assigned by the associated students of Brookdale Community College and the Office of Student Life & Actives. a. The advisor shall be a regular employee of the college. The duties of the faculty/staff advisor will be as defined in the rule of the Brookdale Club and Organization Advisor. The faculty advisor may participate in all activities of the organization. The Office of Student Life and Activities will appoint and advisor each April. Appointments will begin July 1<sup>st</sup>, in conclude June 30th, of the following year.

X. This organization shall abide by all applicable rules in regulations of the college and under the privileges as granted by the Associated Students Brookdale Community College. The rules and regulations are found in such documents as the Brookdale Community College Catalog, the Student Handbook, as well as the general regulations of the College as provided by the Board of Trustees, by the State of New Jersey, and the Federal Government.
