Article I

Article II

The Fashion Club of Brookdale Community College is a place to express artistic freedom in the fashion world. This fashion club will be a place to better yourself, network with others and share ideas with other students and faculty on campus. We will branch ourselves throughout the fashions community on and off campus. Members will gain up to date knowledge out of classes and in meetings we have. Doing this will help members grow, develop and express themselves in a mutual love for fashion.

Article III

Full membership in this organization shall only be available to students of Brookdale Community College, regardless of race, color, gender, sexual orientation, or political, ethnic,or religious affiliation. this organization shall not limit any member in the enjoyment of any right or privilege, advantage or opportunity.

## Article IV Execu

**Executive Committee** 

Section 1- The Executive Committee shall consist of President, Vice President, Secretary and Treasurer. Students who serve in these leadership positions must be currently enrolled for a minimum of six college credits (active - not audit status) and must have an acceptable ratio of credits attempted to credits earned (as defined by the college catalog)

Section 2- The selection of this committee shall be by majority vote, with the elections occurring once every fall semester, unless situations warrant otherwise.

Section 3- The President will preside over club meetings and act as a spokesman for the organization. The Vice President will head any special committees and assume presidential duties and responsibilities during the times of the President's absence. The Secretary will keep all records of club meetings and formal business. The treasurer will keep all financial records of the organization, maintain the officers' roster, and prepare the budget for the organization.

Section 4- Vacancies will be handled in such a way as to maintain a minimum of two officers in the organization at any given time.

- Article V- Meetings will be held at least three times a term during a period of time selected so that the majority of the organization's members can attend and participate. Special meetings in addition to regular club meetings will be held if conditions warrant.
- Article VI- The size of a quorum shall be at least 50 percent of the currently active membership.
- Article VII- Questions in parliamentary procedure shall be decided by the organization.
- Article VIII- All monies of the organization shall be kept in a special account assigned by the Associated Students of Brookdale Community College and the Office of Student Life & Activities. Use of allocated funds and earned income are governed by the ASBCC Finance Committee Guidelines. Authorized signatures for the check disbursements will be kept on file with the ASBCC Treasurer and updated as needed.
- Article IX
  The advisor shall be a regular employee of the College. The duties of the faculty/staff advisor will be as defined in the Role of the Brookdale Club & Organization Advisor. The faculty advisor may participate in all activities of the organization. The Office of Student Life & Activities will appoint an adviser each April. Appointments begin July 1 and conclude June 30 of the following year.
- Article X
  This organization shall abide by all applicable rules and regulations of the college and under the privileges as granted by the Associated Students of Brookdale Community College. The rules and regulations are found in such documents as the Brookdale Community College Catalog, The Student Handbook, as well as the general regulations of the college as provided by the Board of Trustees, by the state of New Jersey, and The Federal Government.

If a rule or directive from the parent organization is in conflict with ASBCC rules, guidelines or policies, then the ASBCC rules, guidelines or policies takes precedent unless the ASBCC and office of the Student Life & Activities makes an exception. If the rule or directive is in conflict with Brookdale Community College regulations or policies, then the BCC regulations or policies take precedent.

Article XI- This constitution may be amended by two-thirds vote of the membership, provided the amendment was submitted in writing at previous regular meeting, and notice of the proposed amendment was given to all members at least one week before the meeting on the constitutional amendment.
